## Publication of the annual financial report

Intrasense (FR0011179886 - ALINS), a specialist in medical imaging software solutions and Myrian® designer (the “Company”), today announces the publication of its annual financial report for the financial year ended on December 31, 2020.

### Growth of financial aggregates

The annual financial report reflects the Group's positive financial performance, with the main financial aggregates showing an increase despite the difficult economic context in 2020.

These good results illustrate the work of the teams and the outcomes of the Company's structuring. 2020 also marks a new phase in the Group's development, posting operational profitability for the first time of its history.

Intrasense is entering a new phase of growth with enthusiastic technical, commercial and managerial teams and an innovation strategy in line with its growth ambitions in its target markets. The Company's 2020 objectives have been fully achieved and 2021 looks promising. To finance its growth strategy while maintaining a strong balance sheet structure, Intrasense considers raising capital in line with market conditions and the progress of its development plan.

### Main financial aggregates:

- Sales up by 3.7% despite the impact of the health crisis
- EBITDA up by € 554k and at breakeven for the first time
- Cash position strengthened to approximately € 2.5M
- Successful completion of the Group's structuring phase initiated in 2018
